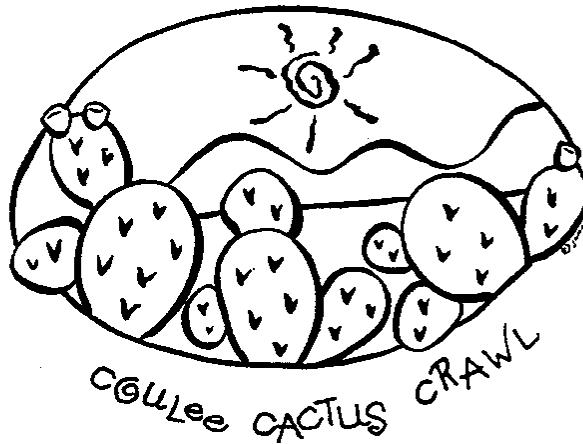

The Course: 20 miles of narrow trails that wind up & up & up, down & down & down and through Lethbridge's river valley. Course is rated as "challenging and cross country". Individual leg lengths will vary.

Please note that the City of Lethbridge has the final say on if the coulees are too wet for racing. In this event a "wet weather route" on shale and pavement is used.

Entry Fee: \$25 before and including May 27th. Late Entry Fee: \$40

Entry Deadline: Entries must be received at Runner's Soul no later than Friday May 27th in order to guarantee a FULL race package. Late entries accepted up to Friday June 3rd at Runner's Soul.

Number Pick Up: At Runner's Soul, Friday June 3rd: 10 a.m. - 5:30 p.m. & Saturday June 4th: 9:30 a.m. - 10:30 a.m.

Awards start following course closure at 3:30 PM.
